LODGE CHIEF'S REPORT

Treasurer's financial records were updated. The following changes were announced to the Executive Committ-Mr. Ray Klaar - HTE Advisor. John Minagro replaced Ken Gilbert as Corresponding Secretary. Gabe Gluck has been appointed chairman of the new Inter-relations Committee. Walt Bailey has replaced Vigil Chairman Ed Albinski who entered the Nationial Guard.

LITTLE LODGE CHIEF'S REPORT

Don Heiberg - In accordance with new national requirements, changes in the Lodge Rules and Regulations have been made.

TREASURER'S REPORTS

The Lodge balance is low because Council payed National Supply bills directly from the Lodge account without telling the Lodge Steps will be taken to insure that this does not happen in the future. The account will be firmly in the black after the summer trunk money from Wauwepex is turned over, and after the Banquet trunk sales eliminate much money tied up in inventory.

The deadline for all petition nominations: FEBRUARY 9, 1968. Any petition received after that date cannot be considered.

The official ballot card will be mailed to all active Buckskin Lodge members with the <u>TAB</u> dated March 7, 1968. On your Scout Honor, only members under twenty-one (21) years of age are permitted to vote. Each voting member may only vote once. The deadline for receipt of the official ballot form is April 19, 1968. No ballots will be accepted after that date.

The Nominating Committee is composed of a chairman and an advisor chosen by the Lodge Chief; two representatives from each district in the Nassau County Council; and any members-at-large appointed by the Lodge Chief.





