Buckskin Lodge Year to Change? NEW TAKEOVER DATE: SEPTEMBER 1

At the November, 1968, Executive Committee Meeting, Lodge Chief Don Heiberg appointed a committee to make an evaluation of the membership expansion effects during the past year and to make recommendations to the Executive Committee. The committee made its presentation at the February Executive Meeting.

A major administrative change suggested is to change the beginning of the Lodge Year from June 1 to September 1. (This change has been approved by the Executive Committee at its March meeting and is pending the approval of the Lodge. For the exact wording of this "Bylaw" change see the article elsewhere in the Tab.) The committee felt that it is extremely difficult for an incoming chief to organize his committee structure in less than a month to efficiently and effectively run the summer camp operation. By changing the transfer of office to September

TAB MAILED SECOND CLASS

For many years, Buckskin Lodge has encountered difficulty with its This has been especially mailings. true of the Buckskin Tab. Local post offices have delayed the delivery of the Tab for many days, seemingly with no reason at all. Having a third class rating, the Tab was held up at many post offices despite the fact that it was marked "DATED MAIL." Thus, there have been many complaints from Brothers who received the Tab late or not at all. Obviously, this has many drawbacks and is extremely inconvenient when deadlines are announced in the <u>Tab</u>. Many Brothers have been unable to attend weekends or activities be-cause they weren't given enough notice. In most cases, this was due to the postal delay. Numerous attempts have been made to correct

20th ANNIVERSARY AWARD CREATED

This year Buckskin Lodge celebrates the twentieth anniversary of its being chartered as a national Order of the Arrow Lodge. In honor of this occation, the Twentieth Anniversary Award was created. Every Lodge member, boy or adult, is eligible to earn the award and each will receive his scorecard by mail.

To be eligible for the award, you have to be actively registered in Scouting and actively registered in Buckskin Lodge for 1970. The requirements of the award are as follows:

BROTHERHOOD--If you were inducted prior to 1969 and are still an Ordeal member, seal your vows in the Brotherhood. If you are already a Brotherhood member, offer your services as a Brotherhood sponsor.

CHEERFUL SERVICE--Attend an Executive Meeting. Serve <u>actively</u> on at least one Lodge committee. Attend a service activity. Serve as a guide or taskmaster on a weekend or at summer camp.

Recruit a new boy or adult into Scouting. If you are under 18, advance one rank. If you are a Life Scout, earn five merit badges. Eagles need not advance. If you are over 18, attend a roundtable and complete a Council -approved train-

EDITOR'S DESK

This issue of the <u>Buckskin Tab</u> marks the first time ever that this publication has been mailed using a second class postage rate. On the surface, this probably doesn't seem like much, but actually means a great deal to most members.

In the past, the <u>Tab's</u> third class rating has caused it to be put aside, delayed, and generally abused by the local post offices. Brothers would receive their issue several days after a work weekend, workday, or other activity which was announced in the <u>Tab</u>. The result: much confusion and disappointment as members were too late to register because they weren't notified on time.

To cite one example, I point out the problem concerning the Hootenanny in March. Special flyers had to be mailed because the March Tab, which contained the Hoot information, could not be relied upon to be delivered before the day of the event. As it was, even the flyers (mailed third class) arrived after the Hoot in some cases.

Nothing the <u>Tab</u> staff or Lodge officers could do was effective in accelerating the <u>Tab</u> delivery. The <u>Buckskin Tab's</u> third class rating automatically gave all other mail priority over it.

With a second class postage rating, the $\underline{\text{Tab}}$ will be at each Brothers hould one or two days after it is mailed. Deadlines now can be set with confidence and adhered to since the $\underline{\text{Tab}}$ mailing will be reliable.

Another indirect advantage for the Buckskin Lodge member will be more money for activities due to

Arrowmen who believe in our high ideals of a Brotherhood of Cheerful Service should step forward and complete their induction by sealing their vows in the Brotherhood membership. All these goals are incorporated in our Twentieth Anniversary Award.

Along with our 1969 charter renewal application, I sent to Mr. David J. Boshea, the National Order of the Arrow Secretary, a detailed report of what we were and are doing to obtain the Boypower '76 goals. In his reply, he stated "If every lodge was doing the job that Buckskin Lodge is doing the Order of the Arrow would make a real impact on the camping program across America. As you know, your lodge means much to me personally because I participated in many fine activities in the lodge during my years of service with the Nassau County Council." We are doing a great job in reaching the objectives of our Order. And if every Brother strives to obtain the Twentieth Anniversary Award, we will all be a part of a Brotherhood that has made a tremendous positive impact on America's future manpower. .

PROPROSED CHANGES

The following are the motions to amend the "Bylaws" and "Rules and Regulations" presented by the Policy Committee and approved by the Executive Committee on March 2, 1969.

The underlined sections are those that are to be changed. A more complete explanation begins on page 1.

"Bylaws"

-- Change of Lodge Year

Article VI, Section 1 (to read) The election for officers of the Lodge shall begin on or after April 1 and shall conclude on or before

Article VI, Section 7 (to read) Officers elected will officially take office on September 1 following election and will be ceremoniously installed on the Lodge's Fall Fellowship Weekend after September 1 or at a time and place selected.

"Rules and Regulations"

-- Additional Unit Election Changes

Article IV, Section 3 (to read) Rank Requirement -- A Boy Scout. must be First Class rank at the time of his induction into the Order. he does not attain First Class rank by December 31 of the year of his election, his election becomes invalid. There is no rank requirement for Explorers, but they must have been active, registered members of an Explorer Post or Boy Scout Troop for at least six months prior to election.

Article V, Section 7 (change last sentence to read)

If any of those elected is an Ea-gle Scout or if (an) Eagle Scout(s) receives the highest vote total, the number of boys to be elected will be increased by the number of Eagle Scouts elected.

-- Change in Lodge Year

Article VII, Section 1, Paragraph 2 (second paragraph to read)

Not later than May 1 the Lodge Treasurer shall call a meeting of the Finance Committee to prepare a proposed budget for the next administration. The Treasurer shall act as chairman, and not less than onethird of said committee shall be composed of adults. The budget shall be presented to the Executive Committee at the May meeting of the Committee.

-- District Chairmen

Article IX (add section 2 to read) SECTION 2 - The Lodge Chief shall appoint a chairman and advisor of each of the districts of Nassau County Council to coordinate the activities of the Lodge within his district and to provide membership to other committees as needed.


Dance Team.

1, an administration would be able to plan for the summer operations on a committee basis and initiate their plans during the summer. More Lodge members, camp staff members, and campers, would be able to become involved in the summer operations before the summer begins.

A related change suggested is to have the officer elections approximately one month later with results being announced in mid-May. The new officers would be able to observe an efficiently run summer operation while carefully choosing their new committee chairmen. By the time the new administration takes office on September 1, they would be familiar with the operation of the Lodge and would be able to smoothly move into the fall weekends and committee operations.

The possibility of dividing into chapters was discussed, but it was decided that chapters too often lead to unnecessary controversy and rivalry within a Lodge. To get more members involved, the committee suggested that more work be done and coordinated on a district level. The Executive Committee has approved the "Rules and Regulations" addition stating that a chairman and advisor be appointed for each district to serve on the Executive Committee and further coordinate the workings of the Lodge and its various committees within his district.

Last fall, the Lodge experienced major overcrowding on the fall weekends due to the large increase in membership and the large number of Ordeal candidates. The committee suggested that this fall the new administration run more weekends. Two weekends should be held consecutively in September at Onteora. A request should be made that Brothers (and candidates inducted on the first weekend) attend only one of the Onteora weekends so that everyone wanting to attend could be accomodated. It is impossible to schedule more than one Wauwepex Fall Weekend because of the tremendous demand for its camping facilities during the fall by units and other council organizations.

To eliminate the problem and confusion in the weekend registration procedure, all fees (including food, lodging, Onteora bus transportation, and candidate's kits) should be paid before the weekend registration deadline. No late reservations should be accepted. Attendance on any weekend should be limited to 400.

The committee has suggested that a special induction be conducted at Onteora at the end of the summer camp season, which would be August 22 and 23 this year. This would not be a fellowship weekend and Onteora summer staff members would serve as taskmasters. Specific details as to who will attend, etc., are being worked out.

Hopefully, with these suggestions initiated, the Lodge will function more smoothly and more on a commit-

this over the years, but to no avail.

An effective solution has finally been found. If the Buckskin Tab were to be mailed at a second class rate, it would take only one or two days to reach its destination without any delays. In effect, it would take the same time as any letter mailed first class once it is delivered to the post office. At the present time, the Buckskin Tab's application for a second class permit is being processed through the Roslyn Post Office. We can foresee no problems in obtaining this permit. All future issues, beginning with this one, would be mailed at a second class rate.

Oddly enough, the second class postage rate is much less expensive than the third class rate we are presently paying. After the initial application fee, the cost will be only a fraction of what it has been. Why is it possible to get improved service at a cheaper cost? We don't know, but we have finally found a way to turn the typical post office confusion to the Lodge's advantage.
