In the Fall 1970 issue of the National Order of the Arrow Bulletin there appeared an article which I thought would be of general interest to the Lodge. It was a letter written by Thomas Fielder, the Chief of the 1969 National Conference. An exerpt from the letter read as follows: "Dear Brothers:

While traveling and visiting many of our lodges around the country. . ., I have noticed, unfortunately, many poor examples of proper uniforming. ... I have seen and heard of many poor examples, but perhaps the most glaring one . . . occurred along the eastern seaboard: The Scoutmaster of a fully uniformed troop was so irked by an election team that he mentioned it to the national office. It seems that the three Arrowmen thought enough of the Order to wear their sashes-but not enough of either Scouting or the Order to even bother wearing uniforms; one even wore blue jeans for the election visit."

The letter was not referring to any Lodge in particular, but I myself know of at least one instance where O.A. members of this Lodge were out of uniform when they conducted an election. Being out of uniform at a unit election gives everyone the impression that the O.A. is an informal organization, whose members turn on to Scouting or turn off to it whenever they please. Wearing the uniform means you are an active participator in the Order and in the Scouting movement. If you are a member of this year's Home Troop elections committee, I trust that after reading this you will not neglect to wear your complete uniform when you conduct elections this spring.

The letter above reminds me of another item concerning O.A. elections that should be brought up at this time. Letters have been sent out to all Scoutmasters and Post Advisors in Nassau requesting them to select a date for their unit's O.A. election. If you are a unit leader and did not receive a letter, you can obtain one at Harkness or by contacting the elections chairman, Scott Wood.

Also, boy members of our Lodge are still needed to conduct unit elections. If you would like to run a unit election in your area, simply contact the chairman Scott Wood and volunteer. With your help and cooperation, the O.A. elections can and will run smoothly during the spring months.

Dear Brothers,

As Brothers of the Order of the Arrow, we all have the common purpose to serve others. It is true that we serve our fellow Scouts through Work Weekends and other means, but the meaning of SERVICE is not and should not be restricted to Scouting alone. There have been some projects devoted to serving the community, such as the recent Canned Foods Drive, but they are few and far between. I am sure that there are many more projects in Nassau County, but people are not looking for them. We can not blame the Committee Chairman, because they can't plan and or coordinate projects that they don't know about. The responsibility of informing them falls on the heads of YOU.

Many troops perform projects that might be a greater success if done on a larger scale. Since every troop has a representative (or should), he could help spread the project to all of Nassau County, through what we might be called an information relay system, by calling his District Rep., who will take it from there.

The Inter-Relations Committee is the largest in the Lodge, because whether you are registered with the current chairman or not, you are in a way a member. With at least one member in every town, it should be very easy to find at least two projects in each district. A small group of people can't do this. Very few people are able to find a project outside of a mile and a half of their homes, simply because they don't know the area. I know I can't, and am sure that many other people can't either.

If you only want to do HALF the job, then you don't have to do anything, but who wants to get half his grade on anything he does. All it takes is some imagination on your part, just say to yourself, "There's a worthy project. How can the OA help?"
