## Vigil Nomination

The Vigil Honor, the highest honor that a Lodge can bestow upon its members, is annually awarded to several members of Buckskin Lodge, on the basis of their service to the Lodge, to Scouting, to their community, and to their church. These Scout, Explorer, and Scouter members of the Order of the Arrow, by reason of their exceptional service, personal effort, and unselfish interest, have made distinguished contributions beyond the immediate responsibilities of their position or office in the Lodge or Scouting.

Do you know someone in Buckskin Lodge who, in your opinion, has rendered exceptional leadership through service? Is one of your fellow arrowmen a truly devoted member of the Order, constantly practicing its principles and traditions?

If you recognize a fellow Brother from these questions, and if you believe that this certain Brother is worthy of and eligible for this Honor, then it is your duty and privilege to nominate him. Don't always rely on someone else to do it—that is done too much today. Be different and make the nomination **YOURSELF!** Any member of the O.A. can nominate someone; you do

not have to be a Vigil member, and you may make as many nominations as you wish. Both Boy and Adult members are eligible, and the names of all nominators are kept confidential by the Vigil Committee.

The only requirements that one must meet for selection to the Vigil Honor are that he must be an actively registered member of Scouting and Buckskin Lodge in 1973 (that means that he must pay his 1973 dues), and he must have been a Brotherhood member for a minimum of two years at the time of his selection (which means that he must have sealed his vows prior to June 1, 1971). If you are not sure that a Brother meets these minimum requirements, nominate him anyway, and his eligibility will be determined from the Lodge records.

In this month's TAB, you will find a list of Brothers eligible for the Vigil Honor this year. Their eligibility, however, is contingent on their payment of 1973 dues, and their registration in Scouting. Look down the list of names and decide whom you feel is worthy of the Order's highest honor, then use the form on the reverse side of the list to nominate that person.

To obtain more nomination forms, call or write the chairman specifying the number of forms that you want. Fill in as much of the form as you can; however, it does not have to be complete—the Vigil Committee will obtain the rest of the necessary information. For your convenience, you may also nominate someone **without the use of the form.** Simply write me a letter and, after officially stating that you are nominating this particular Brother of Brothers for the Vigil, give your personal reasons on why you think he is qualified. The deadline for all nominations is February 28, 1973. Please make every effort to nominate a Brother of your choice before the deadline.

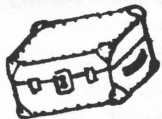
