

In addition to the regular Troop Camping program, Onteora also presents four special programs as follows:

JUNIOR LEADER TRAINING is conducted during each of the four periods. Registration is limited to regular Junior Leaders in Troops, 12 years of age or older, of at least second class rank. Junior Leader fee \$50.00.

CAMP STAFF TRAINING is designed to assist Explorers and Seniors in qualifying for Camp Staff positions. Conducted first and second periods only — fee \$50.00 per period.

ADIRONDACK CANOE TRIPS will be conducted from Onteora during each of the four periods in 1963. Nine days on the Fulton Chain plus training — Fee of \$50.00 covers all costs except bus transportation to Onteora.

DELAWARE RIVER CANOE TRIPS will be conducted during the third and fourth periods only. Training and preparation at Onteora, plus 10 days of real adventure on the Delaware — Fee of \$50.00 covers all costs except transportation to Onteora.

PHILMONT EXPEDITION is without doubt the highlight adventure for Explorers and Seniors (14 years or older). The Nassau County Council will conduct an Expedition to Philmont from July 8 to July 26. Fee of \$250.00 covers all costs including plane fare to and from Denver, sightseeing trips, meals, plus 12 wonderful days at Philmont. Call the Council Office for more details.

GENERAL CAMP INFORMATION

REGISTRATION — Troop camp reservations must be verified as to number of Scouts attending by the filing of individual application and a \$5.00 reservation fee from each Scout on or before April I, 1963. (Reservation fee is not refundable but is transferable to a new applicant). Camp patches will be distributed to Scouts upon receipt of camp application.

Applications for individual Scouts to attend any of the programs listed in this folder are acceptable at the Council Office on or after February 15, 1963. Balance of camp fees are due at the Council Office on or before June 30, 1963.

CANCELLATIONS and REFUNDS — Refunds of camp fees (exclusive of \$5.00 registration fee) will be made under the following conditions:

- Dismissal from camp for medical reasons only refund of unused portion of fee.
- Written cancellation to the Council Office prior to the opening of the camp period.

RELIGIOUS — Scouts are urged to attend religious services of their choice while at camp. Resident Chaplains at each camp are available for guidance and consultation.

HEALTH and SAFETY — Nassau County Camps operate under New York State Health Department regulations. Every camper must present a Health Examination from his own physician to enter camp. A well equipped Health Lodge is maintained and staffed by qualified personnel at each camp. Campers are covered by a Medical Reimbursement Policy as a part of the camping fee.

VISITORS AT CAMP — Visitors are welcome at camp on the middle Saturday of each period between the hours of 2:00 and 10:00 P.M. only. Visitors are requested to refrain from visiting except at the above designated time.

Camp fees at Onteora are based upon the food service plan desired.


Plan I - All food furnished and prepared by the Troop - \$12.00 per period per Scout.
